## **NJRCEV Customer Referral Program Official Rules**

These are the Official Rules ("Official Rules") of the NJR Clean Energy Ventures Corporation ("NJRCEV") Customer Referral Program ("Program"). You must agree to accept and comply with these Official Rules to be eligible to participate in the Program. Decisions of the Sponsor (defined below) are final and binding in all matters related to the Program.

PROGRAM DESCRIPTION: The Program begins on January 26, 2011 and ends whenever the Sponsor, in its sole discretion, cancels or terminates the Program ("Program Period").

ELIGIBILITY: In order to be eligible for the Program, participants ("Program Participants") must meet the following eligibility requirements: (1) must be a legal resident of the State of New Jersey; (2) must be 18 years of age or older; (3) must refer a new customer to NJRCEV for participation in Sunlight Advantage ("Residential Customer"); (4) Residential Customer must be a New Jersey resident; (5) the Residential Customer must enter into a solar equipment lease with NJRCEV under The Sunlight Advantage<sup>TM</sup> program; and (6) the Residential Customer's the Sunlight Advantage solar installation must be fully completed and interconnected to an electric public utility grid. ("Completed Installation").

ELIGIBILITY LIMITATIONS: (1) Program Participants who refer Residential Customers that entered into solar equipment leases with NJR Home Services Company or NJRCEV on or before January 26, 2011 are not eligible to participate in the Program. (2) Program Participants who refer Residential Customers who, on or before January 26, 2011, applied for The Sunlight Advantage installation or applied to New Jersey Resources Corporation, NJR Home Services Company or NJRCEV for any solar energy program or installation are not eligible for the Program, even if the prior application was rejected. (3) Program Participants with an outstanding past due account balance for over 125 days with The Sunlight Advantage are not eligible for the referral bonus unless their outstanding balance is paid in full within 45 days after customer is notified by NJRCEV. (4) Program Participants are not eligible to receive the bonus if they are adding panels to an existing system that is attached to an existing account with their name and address.

HOW TO REGISTER FOR THE PROGRAM: To register

for the Program, the Residential Customer may telephone 1-855- 4SUNLIT during the Program Period and provide the NJRCEV telephone account representative with the name and contact information of the individual who referred them ("referral source"). Each Residential Customer with a Completed Installation is allowed to register only one Program Participant (i.e., only one Program Participant per Residential Customer address). In the event more than one referral source is received for a Residential Customer address, the first referral source received will be considered the only valid registration received for that Residential Customer address.

AWARD: Each Program Participant properly registered by a Residential Customer on or after October 1, 2018, as set forth above, will receive a Amazon Gift Card with a retail value of two hundred and fifty dollars (\$250.00).
